## **PNE 145 PERSONAL VOCATIONAL CONCEPTS**

### **I. CATALOG DESCRIPTION**

- A. Prerequisite and/or Co-requisites: Admission to Bi-Level Nursing program and reading proficiency
- B. 1.5 Credit Hour
- C. Personal Vocational Concepts introduces the beginning student to nursing as a profession and explores the stressors inherent to entry into the role of a practical nurse. The course includes historical aspects, cultural, ethical and legal aspects, professional organizations, and career opportunities of practical nursing (F,S).
